NOMINEE AGREEMENT. This Nominee Agreement (“Agreement”), dated as of the 21st day of September, 2007, is by and between Newfield Exploration Mid-Continent Inc., a Delaware corporation (“Nominee”) and CEP Mid-Continent LLC, a Delaware limited liability company (“Owner”). Nominee and Owner are sometimes individually referred to herein as a “Party” and collectively as the “Parties”.

Nominee Agreement - SEC

For legal purposes, a nominee agreement represents an arrangement in which the owner registers the property in the name of a nominee so that the latter legally holds the property and all the rights related to it such as mortgages, interests, easements, licenses, leases, by-laws and charges. Unlike the owner, the nominee has no beneficial interest in the property.
